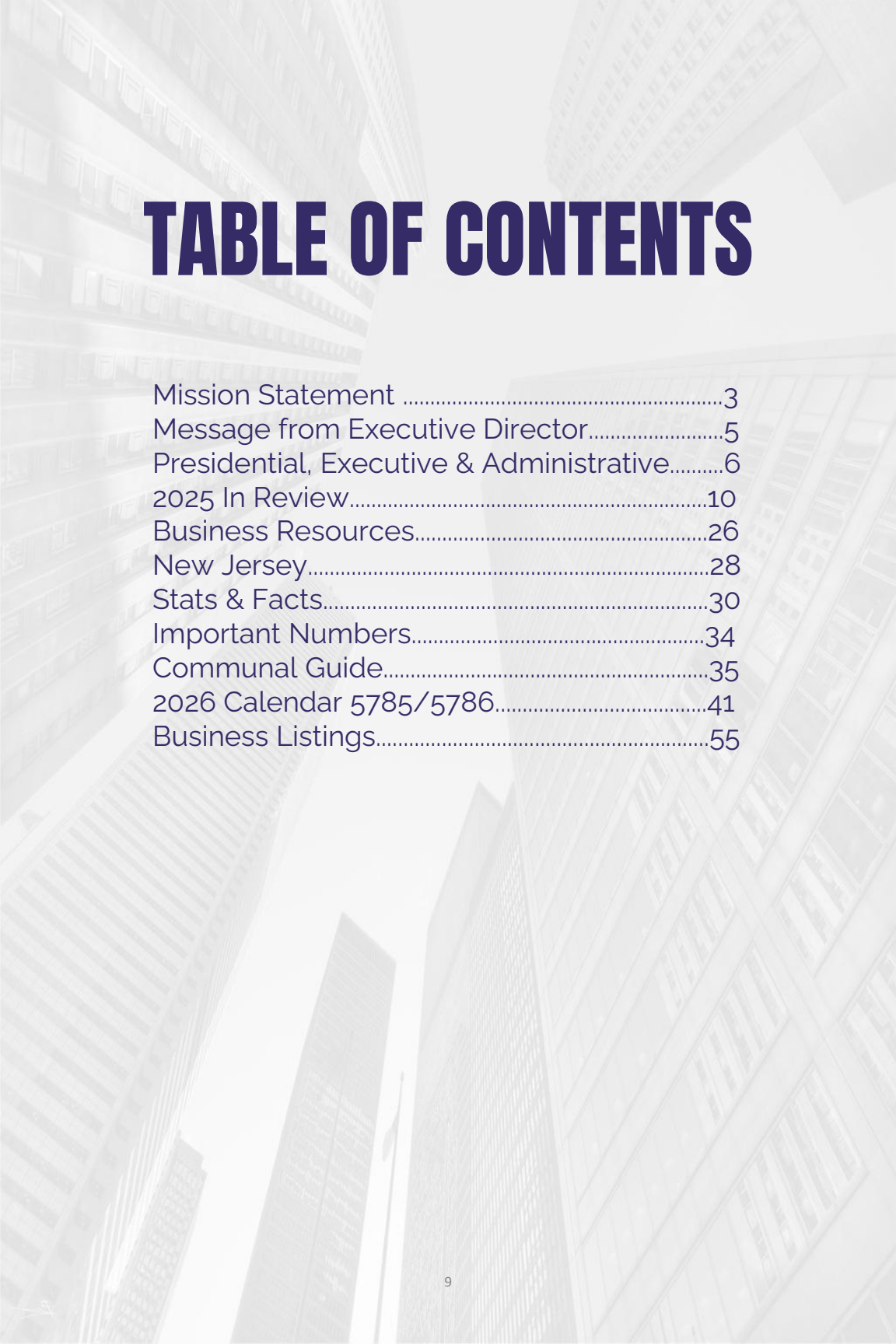

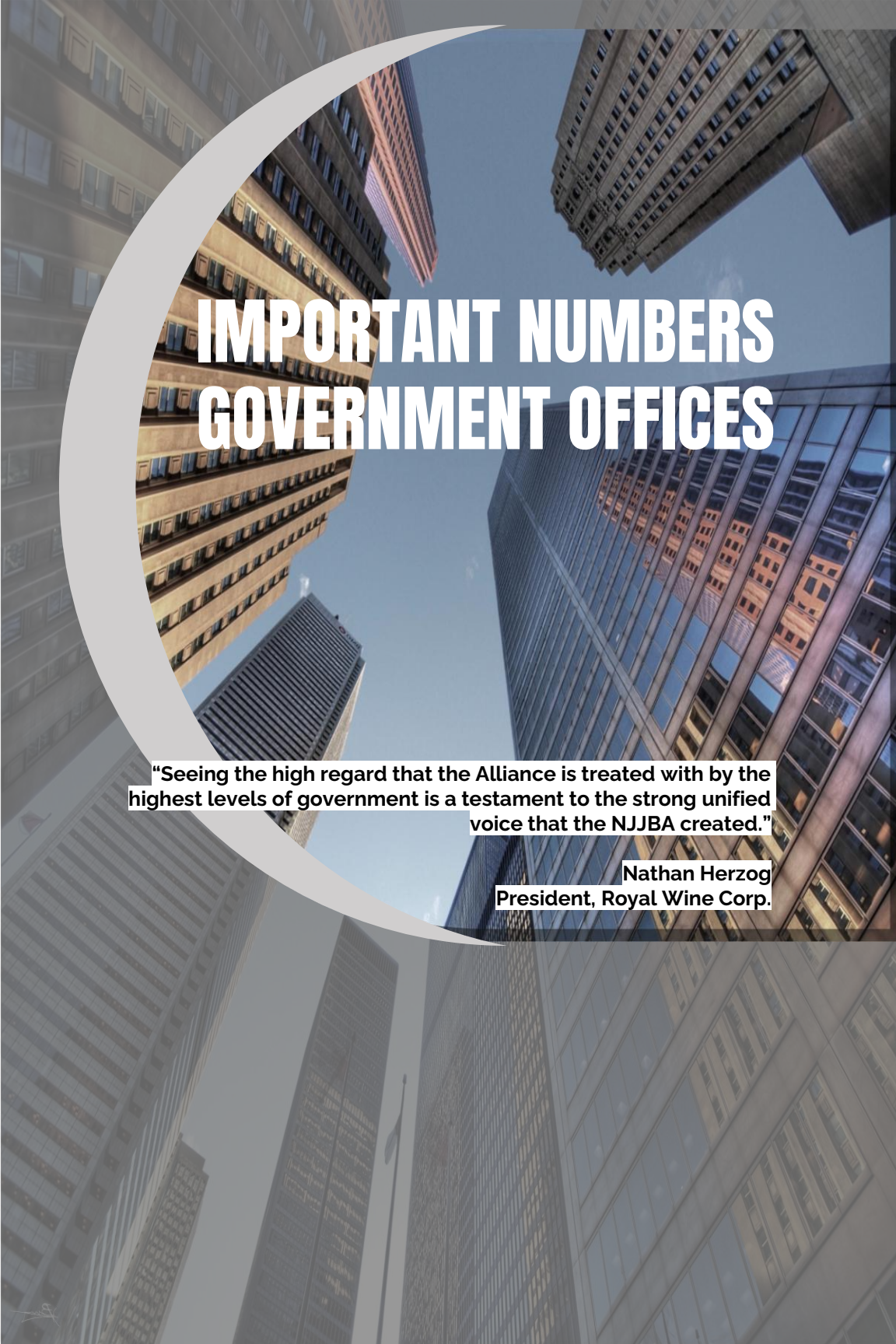

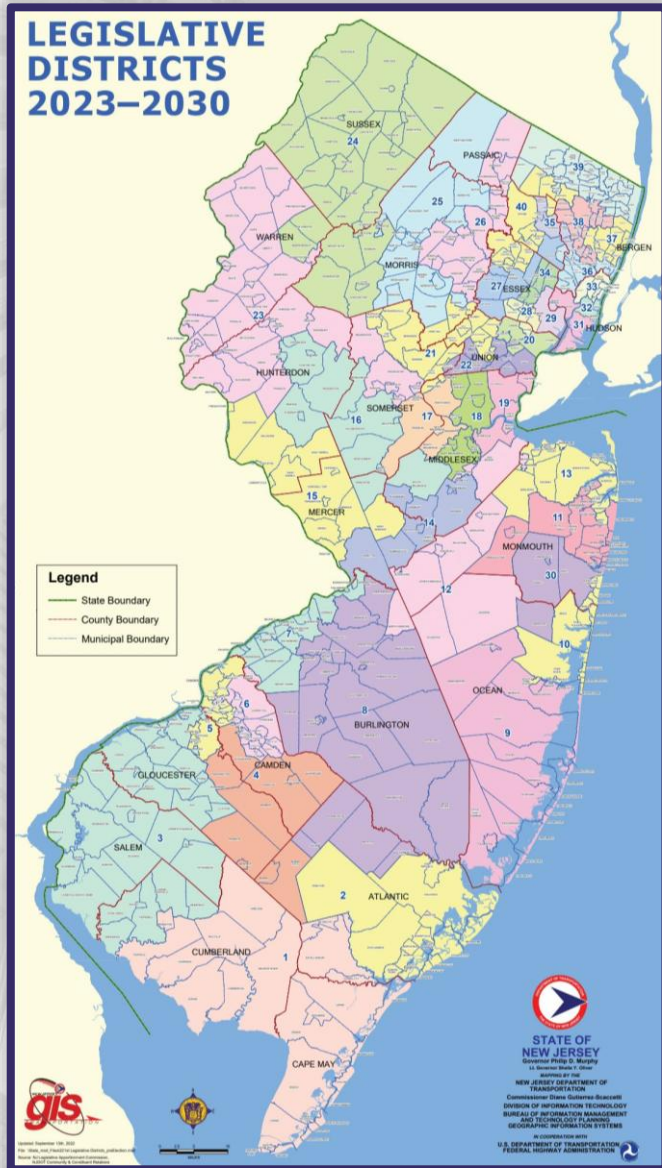

NEW JERSEY



At 7,354 square miles (19,050 km²), New Jersey is the fifth-smallest U.S. state by land area—but with nearly 9.3 million residents, it ranks 11th in population and has the highest population density. Its capital is Trenton, while Newark is the largest city and a major center of industry, culture, and transportation.

New Jersey was first inhabited by Native Americans for at least 2,800 years. Later, the British established the Province of New Jersey, named after the largest of the Channel Islands. During the Revolutionary War, the state earned the nickname "Crossroads of the Revolution" for its pivotal role in battles and troop movements. In 1789, New Jersey became the first state to ratify the United States Bill of Rights.

Following the Civil War, New Jersey grew into a hub of manufacturing and innovation. Thomas Edison's Menlo Park laboratory pioneered electricity and communications, while the state became a center for chemicals, transportation, and pharmaceuticals. Its central location within the Northeast megalopolis spurred rapid suburban growth in the 20th century, though cities have experienced renewed expansion since 2008. Today, New Jersey has one of the most diverse populations in the U.S. Its economy spans biotechnology, information technology, specialized agriculture, and more.

The state ranks among the wealthiest in the country, with the third-highest median household income and the highest per capita rate of millionaires. Its public schools consistently rank among the nation's top systems.

New Jersey also boasts a rich cultural and historical legacy: it hosted the nation's first organized baseball and professional basketball games, the iconic Jersey Shore attracts millions of visitors annually, and the Pine Barrens remain home to unique ecosystems and the legend of the Jersey Devil. From politics and science to arts and entertainment, residents of New Jersey have made lasting contributions that continue to shape the nation.



Although New Jersey is among the smallest U.S. states, it has the highest population density.



The most popular state park in New Jersey is Liberty State Park in Jersey City. Built to commemorate the country's 200th anniversary, it offers views of the Manhattan skyline, a memorial for the September 11 attacks, and ferry service to the Statue of Liberty on Liberty Island, just 1,984 ft (605 m) offshore in New York State.



New Jersey generates about \$2.8 billion per year from casino gambling, second only to Nevada—home of the famous Las Vegas—which brings in \$7.8 billion.



Ellis Island, part of the Statue of Liberty National Monument, is claimed by both New Jersey and New York. The two states disputed ownership for years until the U.S. Supreme Court ruled in the 1998 New Jersey v. New York case that 83% of the island belongs to New Jersey.



The official nickname of New Jersey is the "Garden State." It was first used to promote farmland in a region of the state known as the Pine Barrens.



Trenton was once the capital of the United States, though the honor lasted less than two months in 1784.



The world's first cell phone call was made by Motorola general manager Martin Cooper, who called from Manhattan to Bell Labs in New Jersey. The world's first color TV was unveiled by RCA at their Camden, New Jersey plant in 1940.



The state has more diners and shopping malls per square mile than any other state in the country.



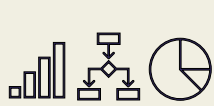

The ice cream cone was invented by Italian immigrant Italo Marcioni, who lived in Hoboken, New Jersey, and pushed his cart across the Hudson River to sell ice cream on Wall Street.



The street names in Monopoly are taken from Atlantic City, on New Jersey's coast.



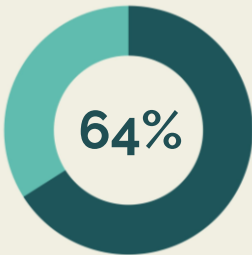
